16-19 Discretionary Bursary Application Form

The 16-19 Discretionary Bursary is a government fund allocated to schools to help students to cover the cost of their education. This is available to students whose parents meet one of the following criteria:

- Receiving Free School Meals
- · Receipt of Income Support
- Income based job seekers allowance
- Support under part VI of the Immigration and Asylum Act 1999
- Child Tax Credits provided the parent is not entitled to Working Tax Credit and their annual income
 assessed by the Inland Revenue does not exceed the maximum allowed (£17,005) The guaranteed
 element of the state pension credit
- Resident in the UK/EU for three years.
- Refugees are not required to meet the three year residency rule if Refugee status was confirmed in the three years prior to starting the course

The bursary can be used to contribute to the following costs:

- · Clothing, books and other equipment for your course
- Transport and lunch on days you study or train
- · One-off payments to cover study trips or travel for university interviews

All applications are assessed on an individual basis. If you wish to apply for the bursary please complete the following form and provide supporting documentation. All details provided are confidential and will only be used to assess an applicant's eligibility. There is limited funding available so all applications need to be submitted by the end of September.
